3.	<u>Eligibility:</u> Who may enter the Competition?”	To enter the Competition, a participant must be 18 years old, and in possession of a valid South African identity document or passport and resides in/around Midrand (“ Participant ”). No Minors are allowed to enter the Competition. Furthermore, a Participant needs to be in possession of an internet enabled device (“ Device ”) such as a cellular phone, tablet, and/or laptop.
4.	Who cannot enter the Competition?	The Competition may not be entered into by any director, member, partner, employee, agent, consultant, tenant of the Landlord at the Mall, the marketing service providers and/or any person who directly or indirectly controls or is controlled by these entities, including their spouses, life partners, business partners or immediate family members.

Follow the prompts to submit the entry; and</p> <p>V. submit your entry (“Entry”);</p> <p>All entries that are incomplete, damaged, defaced or illegible will be void and not eligible for a prize.</p> <p>Upon compliance with (I) – (V) above a Participant will automatically be deemed to have entered the Competition.</p> <p>There are no additional charges for participating in the Competition however, standard data costs apply as per the Participant’s service provider and existing price plan for data usage with regards to uploading his/her Entry.</p>

The prizes	<p>The winner of the Competition shall receive the following prizes (“Prize”):</p> <p>I. x1 (One) R10 000 (Ten Thousand Rands) cash each;</p> <p>II. 6 (Six) months free space in our parking lot at Boulders Shopping Centre (wherein the operation times will be as per stores in the mall 9am - 5pm); and</p>

		<p>III. 1 (One) week free culinary course with the Midrand Cookery School.</p> <p>Note that the prize is not transferable and will not be changed, deferred, or exchanged for cash for any reason whatsoever.</p> <p>Prizes are only valid for the duration stipulated on each voucher. The Prizes are courtesy of the Landlord and subject to the terms and conditions that may be imposed by the Landlord from time to time.</p>
11.	How will the Winner/s be informed?	<p>The Landlord will use all reasonable efforts to contact the Winner during trading hours between 9am – 5pm (“Trading Hours”) telephonically.</p> <p>If the Landlord is unable to contact or reach the Winner within 2 (Two) days of having announced the Winner, the Entry by that person will be disqualified. The Landlord will be entitled to select another Winner thereafter randomly. That Winner will also be contacted telephonically, as soon as reasonably practicable.</p>
