<b>2.</b>	<b>Promoter’s details:</b>	This Competition is conducted and organized by the Boulders Shopping Centre (“ <b>Centre</b> ”), offered by Redefine Properties Limited (Registration Number: 1999/018591/06) (“ <b>Landlord</b> ”) and sponsored by Thaba Eco Hotel in these T’s & C’s, we refer to the above promoter(s) as “the Landlord” and the entrants as “the Participant(s)” or “you.”
<b>IMPORTANT INFORMATION</b>		
<b>3.</b>	<b><u>Eligibility:</u> Who may enter the Competition?”</b>	To enter the Competition, a participant must be in possession of a valid South African identity document or passport (“ <b>Participant</b> ”). No Minors are allowed to enter the Competition.  A Participant must have access the internet. Participants are advised that standard cellular or data rates apply.
<b>4.</b>	<b>Who cannot enter the Competition?</b>	The Competition may not be entered into by any director, member, partner, employee, agent, consultant, tenant of the Landlord at the Mall, the marketing service providers and/or any person who directly or indirectly controls or is controlled by these entities, including their spouses, life partners, business partners or immediate family members.

11.	<b>How will the Winner/s be informed?</b>	<p>The Landlord will use all reasonable efforts to contact the Winner during trading hours between 9am – 5pm (“<b>Trading Hours</b>”) telephonically.</p> <p>If the Landlord is unable to contact or reach the Winner within 2 (Two) days of having announced the Winner, the Entry by</p>

		that person will be disqualified. The Landlord will be entitled to select another Winner thereafter randomly. That Winner will also be contacted telephonically, as soon as reasonably practicable.
